4. <u>How to Submit a Photo:</u> The Submission must be emailed to artshocase@azirish.org. The Photo and Art must fulfill the Submission requirements, as specified, to be eligible to be selected by the ICLF for promotional activity and featured in showcase, as to be detailed by Participant's execution of a separate agreement with the Operator. Entries that are incomplete or do not adhere to the Submission specifications set forth herein will not be selected by the Operator. If a Participant uses fraudulent methods or otherwise attempts to circumvent the Terms and Conditions, the Art may be removed from eligibility at the sole discretion of the Operator. A Photo must not include any of the following: 1) any individual who does not consent to being in the picture, or an animal whose parent does not consent to the portrayal and usage of that Photo, 3) any inappropriate, vulgar, or offensive content, 4) any illegal, immoral, harmful, tasteless, or offensive acts or activities, or 5) any trademarks, tradenames, copyrights, or other intellectual property unapproved by the Operator.

6. <u>Art Selection and Notification</u>: Operator will select the up to fifty (50) Photos by 06/01/20. The Participants who submitted those Photos will be notified by email within five (5) days following selection. The Operator shall have no liability for the Participants' failure to receive notices due to spam, junk e-mail or other security settings, or for a Participant's provision of incorrect or otherwise non-functioning contact information. If a Participant cannot be contacted, is ineligible, fails to contact the Operator within ten (10) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, an alternate Photo and Participant may be selected. Receipt by the Participants of any item of value is conditioned upon compliance with any and all federal, state, and local laws and regulations.
